II. MAJOR PROJECTS

UF - 626 - New Conference Center @ the University House, (Programming) Cydney McGlothlin

Cydney introduced herself as the University Architect. She explained she was presenting the project at the programming phase but that another project manager would be managing the project through the schematic design and design development phases. She showed the location of the project, which was the home of past university presidents until 2006 and has since been used primarily as an event space. The existing building was built in 1953 and is a two-story structure that is national registry eligible.

The new building will be approximately 20,000 SF and will include a small pavilion in the back. The existing building has a few challenges with accessibility and the ability to have indoor events. The committee was concerned about the existing building and agreed to demolition. The project will come back to the committee during the advanced schematic design phase.

The committee asked about the new building and Cydney stated it will be a one-story building in a park-like setting. The committee asked about memorializing the building with a sign. The committee asked about the pool and Cydney responded that it will be removed.
