II. MAJOR PROJECTS

<u>UF – 653 – Architecture Bldg Renovation & DCP Collaboratory, (ASD) Cydney McGlothlin</u>
Cydney stated she was the University Architect and was presenting on behalf of Tamera Baughman, the project manager for UF-653. The project was reviewed for site approval last year and was returning to the committee for ASD approval. The main objective is to bring the building up to code and meet ADA compliance, as well as an expansion.

The Collaboratory is approximately 40K square feet and located northwest of the existing building and east of the Music Building. The facility will include functional creative common space, a research hub, a digital modeling/fabrication space, an educational space as well as a multipurpose hall. Cydney showed the proximity of the project to the historic district and noted that Gator Pond will not be impacted by the project. There will be tree impacts from the addition.

Cydney provided renderings of the addition to show the façade. The north side of the addition will be mostly windows. The committee asked if any part of the existing building would be demolished, and Cydney stated part of the stairwell on the north of the building will be demolished when the Collaboratory is added. The committee asked about the design blending into the surrounding buildings and Cydney stated they would be blending the expansion by using bricks and windows. The project will be presented to the committee again during Design Development. The committee asked how far the building would be from the road as the design team was asked to not encroach onto Stadium Road. Cydney estimated that the new building will be about 30 feet from Stadium Road, matching the setbacks of the Music Building. The committee asked if there will be any open space around the bottom floor. There are some concrete areas that classes can utilize and work as groups. The committee asked about the floor to ceiling windows and Cydney stated this was a rending and the windows will be strategically placed.

III. MINOR PROJECTS

MP07583 – Alpha Chi Omega Renovation (Programming) Fatima Ahm

Fatima stated the project will be a renovation to uplift the front façade of the building and reconfigure the parking area. This project will also put ramps on the side of the front entrance for ADA compliance. She stated the front façade will be painted white over the brick. The parking area is still in the design phase but will include 4 spaces. There will also be an area added for scooter parking for the students.

The committee asked about the parking and the dangers of backing out over the sidewalk and onto 13th street. The design team is working on a design to make it safe for vehicular traffic. There will be a green strip area that will not allow backing out. The committee asked that the design team look at that because of the dangerous conditions. The committee asked about the deliveries for the house and Fatima and Linda stated they would be able to park in the back of the building or on Panhellenic Drive for a short time frame. The committee stated because of the dangers in that area, the suggestion would be scooter only for the students and no vehicular parking. The design team is still working on making it safe, but each house is allowed to have 4 spaces. There are some curbed areas that will not allow vehicular traffic and they will have an exit/entry area designated. The committee asked about the national registry for these houses and Linda stated there was a disinterest from the owners.
