#### **Project Overview**


- The project is located at west side of the Health Center Campus, to the east of Center Drive and north of Archer Road.
- The current program scope is two phases which will include the construction of an approximately 100,000sf addition and the renovation of a portion of the existing building.
- The project is driven by the College of Dentistry to maintain and enhance their programs.
- The existing 500,000sf Dental Science Building was constructed in 1975 and is full. Approximately 170,000sf is occupied by the College of Dentistry.






#### **Site Overview**

- The West Entrance is heavily used by the entire Health Center Campus. Patients & Staff park in Garages II & III and walk through the DSB.
- The addition is expected to impact the west parking lot which is primarily used for accessible vehicles.
- The parking lot is primarily used for accessible vehicles, with 59 total spaces, including 45 Disabled General, and the remaining dedicated for Medical Transport, On-Call, and Service Vehicles.
- Parking impact is unknown at this time but is expected to be significant.





- A topographic & tree survey is in progress. On-site review indicates that the area west of DSB has a scattered tree canopy with several different species.
- There will be at least two additional reviews at the ASD and DD phases of the design.
- The proposed addition footprint is unknown at this time, with proposed tree, parking and sidewalk impacts to be presented at the next review.
- Access to the building will be maintained in the design and during construction phases.





#### **Site Conditions**


- First Floor access is provided at the West Entrance from both the walkway and an accessible ramp from the parking lot



Tree B - Along Center Drive - South of Parking Access




